Upcoming Irrigation and Landscaping Project

The board recently hired Landscape Professionals for the irrigation and landscaping project which hopefully will be completed by May 1. The present system is at least 20 years old and suffers from many breaks in the line with resulting water loss and repair costs. The old polyvinyl lines will be replaced with new Schedule 40 PVC pipe in addition to new emitter lines to current and new plantings.

Along with the new irrigation system, improvements will be made to the landscaping at the entrance to Legacy Villas as well as along 22nd Avenue and Waltann to add more color and better design. A number of the overgrown bushes will also be trimmed back to encourage new growth and better form. They may look scrawny at the onset but should fill in as new growth begins.

Please be patient with any disruptions that may occur while the project is underway.

Dates to Remember

Assessment Fee - April 1

Recyling Tips

Acceptable Recyclables - The following list represents the items that can be placed in your blue curbside container.

Paper products Hard plastic products

Metal products – such as rinsed food cans Glass products – such as empty bottles and jars Cardboard products – clean pizza boxes (no grease, if the bottom is greasy, then recycle just the top half)

REMEMBER: All materials must be emptied of liquids and free of food scraps and grease before tossing them in the container.

Unacceptable Recyclables

Batteries

Soft plastics

Large metal items

Greasy cardboard food containers

Specialty glass items such as lightbulbs and ceramics

Styrofoam, clothing, yard waste

Thin paper products (such as tissue paper and napkins)

<u>Doggie doo doo</u> – The board has also received complaints of dog waste on sidewalks and in the communal area near the mailboxes. Please pick up after your dog. Failure to pick up after your pet (cats as well) is subject to a fine of \$25/occurrence and up to a \$200 municipal fine. Not doing so is not only unsanitary, but is also disrespectful to your neighbors. Residents need to document who, when, and where of the violation and, If possible, take a photo before reporting the violation to the HOA board.

Architectural Committee Update

The architectural committee is considering new exterior paint colors and will inform residents of the new palettes once the committee has reached a consensus. Please don't forget that prior approval is needed before any outside changes can be made and this includes changing exterior paint color.
