#### HOMEOWNER/RESIDENT REMINDERS

#### Trash/Recycling:

Per Legacy Villas Rules and Regulations, <u>trash is not</u> to be put out until the evening before scheduled pick up and containers need to be placed behind gates or in the garage by noon of the day following pick up.

Containers are to be at least four feet apart and placed on the street, not the sidewalk, per City of Phoenix guidelines.

Plastic bags, with or without trash, are not to be placed in the recycling containers.

#### Animal Refuse:

Please pick up after your pets. This is not only common courtesy but a sanitation issue as well. You can be fined for not cleaning up after your pets. This includes all private property as well as common areas (including along 22<sup>nd</sup> Avenue and Waltann Lane).

Per City ordinance, all dogs should be on a leash when walking.

If you see someone violating this policy, please report it.



#### **Overnight Street Parking:**

There is no overnight street parking allowed without a temporary parking permit. Your vehicle can be towed at your expense. Requests for a temporary pass must be received before 4:00 p.m. of the day needed to allow time to contact the towing company. You will have to provide the dates for which the pass is required, vehicle information, and a \$20 deposit which will be refunded when the pass is returned.

#### Walk-Thru Gate:

With school starting soon, please remind your students that they must use the walk-thru gate to get to/from the bus stop. They should not push through the main gates. This can damage the gates and you could be held liable.

Please also make sure the gate is securely closed after passing through.
