#### **Annual Meeting**

The Annual Meeting of the Legacy Villas Homeowners Association will be held on Wednesday, November 16, 2022 at 6:30 PM at

Deer Valley Community Center Meeting Room: 8 2001 W. Walhalla Lane (off of 19<sup>th</sup> Avenue, before the 101, parking west side of building)

A 10% turnout of eligible voters (homeowners) is required for a quorum. Please plan to attend and participate in decisions which affect you and your property as well as our community as a whole. Each Unit/Lot is entitled to cast one vote. If there is more than one owner per lot, please designate one individual to cast a vote for all. Owners must be current on all assessments, monetary penalties or other fees and charges in order to vote.

Agenda items include: overview of current year activities, current financial status, future projects, adoption of the annual budget, election to the Board of Directors, and residents' questions and concerns. An agenda and voting materials will be mailed before the meeting. However, homeowners are urged to attend the meeting in order to learn first-hand what is happening in the community.

#### **Call for Candidates – Board of Directors**

In order to prepare ballots and other information for the Annual Meeting, the Board is issuing a Call for Candidates to serve on the Board.

Members serve for a two-year term on a staggered basis. While it is possible to have up to nine Board members, the Board has determined that the composition should be seven members. The Board generally meets once a month for about an hour. Members may be asked to serve on other committees or to assist with Property Maintenance Inspections or other special projects.

There are currently six members serving on the Board. The terms of current Directors Jenifer Lovejoy and Susan Morgan expire this year. Both are seeking reelection. Aaron Claremont has recently resigned. We thank Aaron for his service on the Board as well as on the Architectural Committee.

#### **Architectural Committee**

The Architectural Committee is composed of three or more representatives appointed by the Board of Directors. The Bylaws state that members <u>need not</u> be a member of the Board of Directors or an officer of the Association. No special qualifications are required for membership. The term of office is one year. Terms expire in December.

The duties of the Architectural Committee are to consider and act upon any and all proposals or plans submitted to it pursuant to the terms of the CC&Rs.

#### Rental Unit/RV Parking Survey Results

Thank you to all who participated in the recent survey. The results were 27 in favor of amending the CC&Rs to limit the number of rental units and 27 not in favor.

With regard to changing the minimum time for a lease, 25 did not wish to change the current CC&Rs from 30 days, 29 were in favor of changing to a longer lease (this has short-term rental implications).

The RV Parking issue failed 31 to 23.

The rental issues will be discussed more at the Annual Meeting.
