#### Complaints/Violations

The following complaints/concerns have been received from residents regarding issues not in compliance with the CC&Rs or other Rules and Regulations of Legacy Villas, or which may cause damage or harm:

- Cats roaming freely and defecating on property of others
- Not cleaning up after your dog/excessive barking
- Trash cans left at the curb after pick-up, or not placed at the <u>edge</u> of the sidewalk or in the street before, thereby impeding pedestrian traffic on the sidewalk
- Vehicles blocking portions of the sidewalk
- Inoperable or unregistered vehicles
- Excessive speed in neighborhood (15 MPH)
- Untrimmed bushes/trees; falling leaves; weeds
- Garage doors left open when not being used for ingress/egress
- Items in front yard that may be deemed unsightly
- Draining pools into the street or common area
- Leaving the pass-thru gate unlocked
- Entering the exit gate during malfunctions (use 19<sup>th</sup> Avenue entrance)
