## **Traffic & Pedestrian Safety**

- The posted speed limit is **15 mph**.
- Please drive slowly and remain alert for pedestrians and children at play.
- When using the pedestrian gate, please ensure the gate is closing. If you need a key for the walk through gate, send an email to request one.

## **Trucks, Trailers, Campers, Boats and Motor Vehicles**

Vehicles ***may not be*** constructed, repaired, or stored in an inoperable condition on any lot or street if visible from other lots, common areas, or streets, except for emergency or temporary repairs.

## **Business or Offensive Activities**

No nuisance or offensive activities are allowed. In addition, properties ***may not be*** used for business, commercial, institutional, or similar non-residential purposes such as child daycare.

## **Trash and Street Sweep**

- Holiday Changes: Expect delays if your pickup falls on Thanksgiving, Christmas, or New Year's Day; collections shift by one day.
- Bulk Trash (Schedule Appointments): You must book online; place items out no sooner than 7 days before your confirmed date, by 5:30 a.m.
- Street sweeping will be conducted during the day on the 3rd Thursday of Feb, May, Aug & Nov. Please try not to leave your vehicles on the street on those days.
